

"I Don't Know Why Police Killed Him"

Police shot and killed a 26-year-old mental patient from Ypsilanti State hospital while attempting to get him to return to the institution.

The victim, Julius Malone, of 3849 29th, was killed in the kitchen of his home early Monday morning while he held police officers at bay with a knife.

The dead man's wife, Mrs. Patricia Malone, 23, of the same address, said her husband had left the grounds of the hospital and came home to visit her and their three children. When she realized he had not been authorized to leave the grounds of the

hospital, she stated, she called the city Physician's office Sunday.

She said the city physician did not appear until late that night and refused to take action until the following morning when police accompanied him.

Mrs. Malone said when the officers came on Monday morning, her husband was still in bed. She said he dressed and went into the kitchen to get a match from a kitchen drawer. After getting the match, he took a small boning knife from the drawer and told the officers that he was not going back to the hospital.

According to Mrs. Malone, the officers told her that if she didn't get some help, her husband would be killed. She said she called downstairs and the man who lived downstairs asked the officers what they wanted. In answer to their request, he allegedly called for additional police help.

When the additional police cars arrived, Mrs. Malone said several of the officers entered the house with their guns drawn. She said the officers picked up chairs and backed her husband against the kitchen wall.

The police report indicates, however, that Malone lunged at one officer after knocking the chair from his hand, and attempted to stab him. At this point, another officer shot and killed the deranged man.

The dead man's wife denied seeing her husband attempt to stab the officer. She said that, most of the time, her husband was standing in the kitchen smoking and holding the knife in his right hand down at his side.

Officers said Malone told them the only way they would take him back to the hospital would be dead.

The deceased man was the father of three children and had been a patient in Ypsilanti for several months. His wife said this was not the first time he had left the grounds of the hospital without permission.

In discussing the incident, the bereaved widow said, "I don't understand why, with all those police officers present, they had to shoot him. I had told them to leave because I didn't want him killed."

Several weeks back, while discoursing on that ever popular Doo-It Store subject, shelving and wall units, we suggested that decorative wood trim applied to wall furniture adds a whole new decorating dimension. Our newest display utilizes the trim instead of wood tape for shelf edges, and we have extended the use of decorative wood to the metal wall strips as well. The results are striking.

Now we would like to suggest you take a long, hard look at your present shelving. There it is, very nice to be sure, but the same yesterday, today, and most likely, tomorrow, too. Whether just a desk unit and a couple of shelves or a complete wall, built-in or free-standing, your units represent a considerable investment and the chances are you plan to keep them. But that need not preclude a change. Dress up your shelves with decorative wood strips just as we have, using either $\frac{3}{4}$ inch to fit exactly or wider to give a scalloped appearance above and below the shelf.
