the car to the call box. His name is Ernie Stringer. When he got to the call box, one of the policemen snatched him out of the car and asked him, "dive me your license, you are drunk." Ernie gave the policeman his license and the two of them started arguing. Then the people in the car that Ernie ame driving, Bobby Stringer, Al, Pauline Goedner, Rosie Stringer, Emmorell Legett and Ell Legett got out of the car to quiet Ernie. Everybody rushed to him to stop him from doing anything. Then, the officer Hadge #300 hit Emmorell in the back with his fist and then pushed her. She said, "Ch, you hit me in the back and l'm pregnant." The officer seld, "You're not pregnant." Then, six squad cars and two detective cars came. Emmorell asked one of the policemen in the car to take her to the hospital. The policeman said, "Ckay lady." She got into the car and the next thing she knew, she was at the St. Jean Police Station. As soon as she entered the police station she passed out. She fell and hit her head on something that felt like Iron. A knot appeared on her head. Her husband, Eli, put her on the bench. She wanted him to get her some cigarettes. After going for them, the officer dragged her husband back into the room, without allowing him to get the cigarettes. Then she got up to get them and one of the officers slamed her up against the wall. Her husband sat her down on the beach. Her girlfriend, Pauline Goodner, tried to fix her strap where the police had broken it and put her coat around her shoulders. Then, the police pushed Pauline and tore her dress and threw her into a cell. Then a officer asked Emmorell dim she want cigarettes and she said, "I sure would like to have some." He said, "well follow me." He led her to a

cell and locked her up. Emmorell said she felt as though she was threatening a miscarriage. She is four months pregnant. She laid on a hench in the cell for about three hours before they took her to Receiving Hospital.

As seen as she got there, they put her on a streacher and handcuffed her by chains until about 12 noon Sunday, October 10, 1965 before they examined her. After this, they took her to 1300 Reaublen and she stayed there until October 11, 1965 when they had the trial about 2:00 P. M.

The trial was postponed until November 2, 1965 at 9:00 A. M. Pauline and Emmorell are both out on personal bonds of \$500.00 Ernie got out on a \$150.00 Bond. Donald is charged with \$239.00 for tickets. They said the charges on Emmorell were obstructing and resisting an officer from his duty and they dropped the charges to assault and battery on an officer.

Subject states he was driving on Beechwood Street about 10:00 A. H., October 24, 1965, when a police car pulled up behind him at the stop light. I pulled off and the police did the same. When I got to 28th Street, the police signaled for me to pull over. The colored officer got out of the police car and cause over to my car and said, "that I was speeding down Beechwood". I said, "that I was not speeding". He said, "go to 12th Street and Harren and park your car". After making a call to Police Headquarters he said, "that I had some tickets that was not paid for and that I would have to go to the

minth precinct", located on McGrew and Martin Street, We left 12th and Warren Street. I drove my car to languar Street and parked. When I got out of my car, the colored officer got out of his car and grabbed me. I refused to let min manhandle me. He seid, "that he was searching me". I said, "that I was no orininal, I would rether be searched at the police station". Then he said, "get into the police cor". As I was getting into the cor, they grabbed me and tried to throw me into the cor. Then they tried to throw me into a tree. The white officer tried to hit me with a Blackjack, he missed, thus he came back with his elbow hitting me in the right eye. He sliped and fell, cracking his knew on the concret. The colored officer tried to push my head down to the ground. Them they handouffed me and put me into the police car. The officers were using profemity words. They took me to the sixth precinct and booked me for Resisting Arrest. After that they took me to Receiving Respital. I was given medical attention, was there about two hours. After that I was taken back to Police Headquarters. The officer who was injured, threatened me. He sold, "when he got back on his feet we would have another go at it". I stegred in jail until October 25, 1965, was released about 1 or 2:00 F. H. that day. My Bond was \$1,000 (One Thousand Dollars). I do not know my trial date as yet. Boston Bond paid my bond money.

Subject states that police stopped him and said he was speeding. They took him to a call box. They were calling to see if he had any tickets. Then they said they were going to check to see if Ernie had any tickets. Donald said that he saw the policeman hit Emmorell when she was on the street. She was trying to quiet Ernie down when the policeman hit her. While at the police station, he said he saw the policeman take his body and push it up against Emmorell. Then, Pauline got up to ask the policeman why he pushed a pregnant woman and he tore her dress. Then one of the policemen told the officer to put Pauline in jail. He picked her up and threw her in a cell. After this, they put Emmorell in the cell with her. They took his fingerprints. Then locked him up. They charged him with tickets. He got out on a \$200 Bond. They're trying to change the charge to reckless driving.

Then they put him in a police car and drove off with him. Then everybody in the car said, "Let's follow him." Ernie got in the driver's seat and they followed the police car to Chapin & McCellan. One of the policeman came over to the car and asked Ernie for his license and Ernie said, "what for." Then he pulled Ernie out of the car and acted like they were going to hit him. Then Robert got out of the car and the policeman grabbed him. Another policeman came over and he pulled his gun on him. Then everybody got out of the car to quiet Ernie because the policeman was still arguing with him. After trying to get Ernie quiet down, Emmorell continued to talk to him and then he said he saw the policeman's hand go up as though he was going to hit her. After getting Ernie back to the car, the policeman took the keys and said he had every right to have them. Then he got in the car with Donald and the police told Donald to follow them to the station. They told Emmorell they were taking her to the hospital. Robert, Pauline and Alvin were sitting in the lobby after arriving at the station. "Baldy" he called him, started calling them "Black Muslims". Then he heard a lot of noise in the detention room and he looked and saw the policeman push Emmorell against the wall. He tried to go into the room but one of the detectives pulled a gun on him. He told him he had better not touch the door but Pauline managed to get in. Two detectives asked him if he wanted to make a statement. Then took him into the room to try and get him to sign a statement but he wouldn't. He asked how much was the bonds? Ernie's was \$150, Donald was \$275. There was no bond for Emorell.

Subject states that the policeman stopped them when they were on their way from a reception and told the driver, Donald Rowell, that he was speeding. Then they asked him for his driver's license. Then they put him in the squad car and drove off with him. Ernie drove the car around to the call box where the policemen had taken Donald. The policeman came over to the car and pulled Ernie out. Ernie and the officer started arguing. All of them got out of the car to quiet Ernie down because the policeman had taken out a stick to hit him. Then Rosie said she heard Emmorell say, "Don't hit me no more." After getting Ernie away from the policeman, he continued to "nag" Ernie trying to make him do something. Then she said about three or four police cars came. She said she and Ernie got in a police car and the policeman told Donald to follow him in his car. They thought they were taking Emmorell to m hospital. After they got into the detention room, a policeman called her and asked her what happened. She told him just what happened. She said he asked her if she saw Emmorell get hit and she raid, "No." While sitting in the room, Emmorell wanted some digarettes and she maked one of the officers could she get some and he said, he didn't think so. So she said, "I want some cigarettes and started to the door and this policeman put his body up against her and pushed her up against the wall. Pauline came in and said she would get the cigarettes and the policeman said, "Get out of here." Pauline said, "Wait a minute." Then the policeman snatched her by the arm and put her in a cell. Another policeman took Emmorell by the collar and put her in a cell. They told Ernie they were taking him to 1300 Heaubien for a balloon test because they believed he was drunk. After sending Ernie to 1300 Beaubien they let Rosie and Eli go.

Subject states police stopped them on McCellan and asked Donald for his driver's license and registration and then the policeman said, "if you think that's funny, you will appear in court Monday morning." Then he took Donald out of the car and put him into the squad car and drove off with him. Ernie got in the driver's sest and followed the police car and it had stopped at a call box. The policeman came over to the car and asked Ernie for his license and pulled him out of the car. Ernie and the officer argued. The officer acted like he was going to hit Ernie with his stick. Then Alvin said the policeman tried to get Ernie away from the car and he said that Emmorell was standing in front of Ernie and the officer had to hit her In the lack to move her out of the way so that he could get to Ernie. After leaving the reception, subject states that they were driving on McCellan when a police car stopped them. A policeman came over to the car and told the driver, Donald Howell, he was driving 50 miles an hour. The policeman saked for his driver's license and took it back to the car and checked it out and then returned to the car and asked Donald to get out. He took Donald to the police car and drove off with him. Ernie Stringer drove the car around the block to where the pelicemen had Donald at a call box. The policeman came over to the car and asked Ernie for his license. Ernie gave him his license. The officer grabbed Ernie and pulled him out of the car. After getting him out of the car, Ernie and the policeman started arguing. Everybody got out of the car and tried to quiet Ernie because he continued to argue with the officer. Then he and his wife, Emmorell, got out of the car and at that time his wife was standing in front of Ernie trying to reason with him and the policeman said, "Get out of the way" and hit her in the back. I told the officer, "You have done it now because my wife is pregnant." He maked the policeman, "Why you want to hit my wife, she wasn't doing anything." After this, he led Ernie to the car and put him in it. At that time, several police and detective cars came. Then, his wife started complaining about her back. His wife told police officer #300 she wanted to go to the hospital and he told her to get into a car and he got in with They thought they were on their way to the hospital. He heard one of the officers mention the 5t. Jean Station and then he realized that he

was on his way to the station. After realizing this, he told them his wife was hurt and that they should be taking her to a hospital. They continued to drive to the station. After erriving there, they took them into a detention room and as soon as his wife entered the door she fainted. She fell to the floor and he stood there looking for help to sat her on the beach. There were approximately eight or nine rolloemen I-okina at him and they laughed. He then managed to put her up on the beach. A policeman called, "Saldy" came over to his wife and took his two fingers and opened up her eyes and said, "You mean she is so delicate that she had to faint." When she came to, she caked him to go and get her some digarettes. When he walked to the door, It was locked. Then "Baldy" came and grabbed him between the shoulder blade. Then, his wife said, "I'll go." She started to co. Then the policeman, "Baldy" took his body and pushed it against his wife and she landed up against the wall and her head hit the wall. Then Ell said to Ernie, "if he didn't have that hadge and a gun he wouldn't be so tough. Then "Baldy" led him out of the room to a small room and closed the door. He opened his hands and stretched his arms out and said, "Now we are in a room by ourselves and I don't have a badge nor a gun, now what are you going to do." He told him he was too old and if he hit him, he would never get out of that police station. The policeman said, "I ought to crack your head." He took him back to the detention room. After returning there, he asked them

where was his wife. At that time, they told him that his wife had been arrested and Pauline was going to 1300 Beaubien and his wife to the hospital. Rosie Stringer asked them, what they were going to do with her husband, Ernie. They said they were taking him downtown to give him a balloon test. Then Rosie asked them could she and Eli go and they told her to sit down and they could go in a little while. They sat down and then he told them they could go.

while at the station, Eli asked them what they were holding his wife for and they told him resisting and obstructing an officer from his duty. He called Receiving Hospital after he got home and asked about his wife. They told him that she was there under police custody and he asked if he could get her out on bond and they said, "No bond."

Out of the four people arrested, his wife was the only one that couldn't get out on bond.
