A Back up to my cellblock, 2124.

Q When -- what was your medical condition at that time?

2 A Well, I started to bleed. I lost my baby while I was in the

4 Q While you were in the hole?

5 A Yes.

6 Q What happened to the fetus?

7 A It was in the toilet. I told Mrs. Atkins and she said,
8 "bullshit."

9 Q Who is Miss Atkins?

10 A A cop at the Wayne County Jail.

11 Q That occurred in the hole?

12 A Yes.

13 Q Did you get any attention for that problem?

14 A No.

15 Q Did you get any sanitary napkins?

16 A No.

17 Q Did you ask for any?

18 A Yes.

19 Q Upon your return to the ward, how were your wounds and how
20 were you otherwise feeling?

21 A I was sick.

22 Q Did you make any requests during that period of time for any
23 medical help?

24 A I did.

25 Q How often?

A Every time somebody came on the ward. They decided to give

me tranquilizers.

Q What happened next?

A On the 12th they all of a sudden -- I had an appointment to go back, but on the 12th they decided to take me back.

A I didn't receive any. They said the date was cancelled and there was no clinic. They made it another time.

Q When you went on the 21st, Miss Ware, they told you to come back when?

A One week. Come back in one week.
