of his car. The police then snatched the driver's license and started beating him very violently. The police dragged Robert and the other two boys to the (One) (Two) police car. (Chester and Charles Smart) The officers drove away and when they had gotten further away from the neighborhood, the police started beating, kicking and harassing Robert Wynn and the other two boys. One officer took a razor and put it to Robert's neck and asked him, How do you like the feel of this razor? The officer started beating the youth's head against the door and striking him continuously in the face. The boys were taken to the Davison precinct. Robert Wynn was taken to Receiving Hospital for treatments. He stayed in Receiving Hospital all night. The parents of Robert were notified that their son was in the hospital but they could not release him at the present time. The boy was released from the hospital and taken back to the Davison precinct. The parent's of Robert went to the Davison precinct to get their son released but the Desk - Sergeant said that he could not be released. The parent's were asked to go home and call back later to see if he would be released by 3:30 P.M. Mr. and Mrs. - Wynn called back around 2:30 P.M., and were told to come, and pick up their son at 3:30 P.M. Robert eye was slashed so severely ti required eight stitches to (Robert) close it. The boy suffers from heart trouble. Robert was accused of carrying a knife but the youth did not have a knife on his person and he had never carried a knife before. Rober has never been involved with the police before and has no police record.
