1 fatal shooting of John Doe #465 tentatively identified as James Henderson wearing Black Sweater and yellow pants and a black short wig.

While working plain clothes and assigned to STRESS--1 and on foot in the area of Woodward and Charlotte H&M Writer was approached by N/M later I.D. as John Doe #465 and subject asked writer if he would like a girl. Writer stated that he would like directions to the Tuller Hotel. Subject asked writer to step into the hallway. At this time John Doe #465 produced a 3" knife and placed same to writer's H&M throat and demanded writer's wallet. #1 approached from down the hallway and stated to #2 "Get his wallet!" #1 observed Patrolman PETERSON entering through the front door. #1 then stated, ITS THE POLICE. At this time H&M Def #2 released Patr. Brown and both Defs. ran towards the rear of the bldg. Both Patr. Brown and Patr. Peterson yelled, POLICE, HALT, however Defs. failed to heed their warnings. Patr. Peterson fired 1 shot from his priv. owned, Dept. approv. 38 cal S & W rev. mod. 49, Ser # 9J9715. Patr. Brown fired 4 shots from his priv. owned, Dept. approv. Colt cobra rev 38 cal. Ser. # 259315. During the chase through the hallway which twisted and turned, Patr. Brown fired 3 shots. At the end of the hall, Def. #2 entered a bedroom and was pursued by Patr. Brown and Patr. Peterson. Once in the bedroom, Both officers heard a noise behind a closed door which later turned out to be a bathroom. Patr. Brown knocked on the door, ordering Def. to come out, police. At the time, Def. yelled, GET OUT OF HERE, I HAVE A SHOTGUN. Patr. Brown then fi

his final shot through the door. Patr. Brown and Patr. Peterson then forced the door open and found Def. # 2 lying on the floor apparently wounded. During this same period of time after hearing the shots fired, Patr. Ziolkowski and Patr. Worley ran into the bldg. and apprehended Def. # 1 as he ran out of a door leading into the hallway with a can of paint in his hand. Def. # 1 yelled, GET OUT OF MY WAY OR I WILL KILL YOU MOTHER-FUCKER as he threatened the undersigned with the can. At this time Patr. Ziolkowski tackled Def. around the lower legs and Patr. Worley grabbed him around the head. A struggle ensued, whereupon Def. was taken into custody. Patr. Peterson called for assistance. Def. # 2 was conveyed to Det. Gen. by Sgt. 1-9. Def. # 1 was conveyed to the Det. General by Sgt. 1-9. Can of paint in possession of Def. # 1 placed on Ev. tag # 982141. Wig-female worn by Def. # 2 placed on Ev. tag # 982140. bone handle knife, 3" blade in possession of Def. # 2 placed on Ev. tag # 982139. 4 spent shell casings from Patr. Brown's gun placed on Ev. tag # 982142. Patr. Peterson's spent shell casing placed on Ev. tag # 982143. Def. # 1 was injured in his struggle with Patr. Ziolkowski and Patr. Worley. Patr. Ziolkowski was also injured.
