TEACH-IN OFFICIALLY CALLED "INTERNATIONAL DAYS OF PROTEST" SPONSORED BY: DETROIT COMMITTEE TO END THE WAR IN VIETNAM (DCEWV) FRIDAY, OCTOBER 15, 1965, FROM: 11:00 A.M. to 3:10 P.M.

Friday, October 15, 1965, at 11:00 A.M., The Detroit Committee To End The War In Vietnam sponsored a "TEACH-IN" on the MALL of the KRESGE SCIENCE LIBRARY AUDITORIUM, WAYNE STATE UNIVERSITY, and is officially referred to as "INTERNATIONAL DAYS OF PROTEST" and held in about 60 cities across the United States.

The Detroit Committee to End the War in Vietnam, a campus based organization was formed on February 22, 1965, by students at Wayne State University. Activity by this group on campus is held under the auspices of WAYNE COMMITTEE TO END THE WAR IN VIETNAM, and is a recognized on campus organization. Membership is composed of persons active in other on campus liberal and left wing organizations, such as: W.E.B. DU BOIS CLUBS OF AMERICA, SOCIALIST WORKERS PARTY, YOUNG SOCIALIST ALLIANCE, STUDENTS FOR A DEMOCRATIC SOCIETY and STUDENTS NON-VIOLENT COORDINATING COMMITTEE. According to leaflets distributed by this element, primary demands are: Stop The Draft - End The War Now - Bring the Troops Home. This same group was responsible for the mobilization of local youth to the April 17, 1965, "MARCH ON WASHINGTON" to protest U.S. action in Vietnam. The March was called by the STUDENTS FOR A DEMOCRATIC SOCIETY (SDS), a nation wide organization."

This campus based group is urging high school and college students throughout Detroit who are against what they term "unjust war" to form campus committees and carry out educational programs to win support for their well organized massive resistance to the DRAFT and outright opposition to U.S. policies in Vietnam.

The Detroit Committee To End The War in Vietnam, as well as other on campus based organizations protesting the DRAFT and American policy in Vietnam through out the country, have strong overtones of Communist Party and Socialist Workers Party infiltration and control.

This highly publicized "TEACH - IN" came to an end at 3:10 P.M., about two hours before it was originally scheduled to end. About 400 persons, mostly students gathered in the MALL which faces Second Avenue, just South of Kirby Street, Detroit. About 60% of the audience appeared to be those opposed to U.S. policy in Vietnam, about 25% appeared to be in favor of U.S. policy and the balance were those who remained silent, just listening.

The speakers were called upon at intervals by FRANK JOYCE, 24, of 4825 John C. Lodge, Coordinator of the NORTHERN STUDENT MOVEMENT (NSM) who acted as chairman.

1. CARL HAESSLER, introduced as a former professor and World War one Conscientious Objector, was the first speaker. He advised students of draft age to read up on provisions of the Conscientious Objectors status, listing address, etc. for this data.
