Approx. 2:00 A.M. I Patr. Raymond A. Peterson, # 1506 assigned to Stress and working in plain clothes and in the area of Woodward and Charlotte and walking W. on Charlotte from Woodward was hailed by a col. female dressed to appear as a female from the doorway of 35 Charlotte. (Mayfair Apt.) I approached him and he asked me to follow him. We went to the door of Apt. 102 and upon opening the door I observed 2 col males laying on the bed immediately inside the apt. I stated to the col. female, "Oh no, not all those people in there". She then stated, "thats all right they're leaving". When that statement the 2 men got up and left, dressing first. The col. female then shut the door and stated, "How much money are you going to give me?" I then stated, "forget it, I better leave". The col female then stated, "but let me look in the hall first because, if those guys are out there, they might want to rob you". The col. female then exited the room shutting the door behind her. I attempted to open the door from the inside, but could not because someone was pushing it from the outside. Feeling something was wrong, I backed away from the door. Suddenly the door burst open and two col males rushed in followed by the col. female-male. The foremost col. male (above Def.) was brandishing a raised knife and stated, "I am going to kill you, you white nother fucker". I then drew my priv. owned, dept. approved S & W 38 cal. rev. Ser # 9J9715 and stated, "police officer". At that time the Def. took a downward swing at me with the knife and struck a glancing blow with the back of his hand to the right side of my head and I was knocked to the bed, and at that time I fired 1 shot striking him with same and he recoiled.
