

WE ARE AT WAR (Stress has declared it!!)

Two years ago 16 year old Craig Mitchell and Ricard Buck were shot in the back by STRESS near the Northend Family Center. Should these dead children have defended themselves had they had guns?

What will it take to make Black People understand what is happening to us? Will it be necessary for another Cynthia Scott, Algiers Motel Incident, Craig and Buck, Rochester Street, and many known and unknown cases of police lynchings of Black People in Detroit.

IT IS ALL A PART OF A NATIONAL CONSPIRACY TO COMMIT GENOCIDE ON THE BLACK MAN IN AMERICA!!!

We have asked for the abolishment of STRESS, many prominent Black People have spoken to this issue, Congressman Conyers, Erma Henderson, Ken Cockrell, Jim Ingram, The State of Emergency Committee, and the Black Police

Black Policeman's Association; The Guardians of Michigan. But these pleas were only met with a more intensified STRESS force. The issue is clearly racial.

White people are for STRESS, Black People are against STRESS. They say kill! We say, stop killing us! At this rate, they won't have to worry about Black People much longer.

The Michigan Chronicle reported that STRESS has seized over 1000 weapons in a nine month period. Why do they want to disarm us? And why do they intensify their struggle against us? Who is the real Dopeman?

The Guardians of Michigan released a statement after the December 4, 1972 shooting incident, calling on Black Solidarity amongst Black Police officials (Sherrif Lucas) to end the attacks on Black People in Detroit by STRESS... they say that the People should do something before its too late... and they should know what they are talking about.... after all they are the Police!!!

Is STRESS really necessary to your welfare? Or...What is the strange hook-up between policemen and the Dope racket.

Let's examine some STRESS facts.

On December 4, 1972 when the STRESS mess occurred near U. of D., the news media spoke of the accused Mark Bethune, John Percy Boyd, and Hayward Brown being in the vicinity of a known Dopehouse. It further stated that:

- 1) The occupants of the car, four men poured from a Volkswagon station wagon, firing at the policemen involved before they had a chance to defend themselves.
- 2) On the first day of the shooting, the occupants of the Volkswagon were said to be Black Militants. The second day they were called body guards for the Dopeman. Finally they were called hit men (those who rip off the Dopeman).

All of this activity centers around a known Dopehouse.

Question: How many known Dopehouses are there in Detroit? Why hasn't the police Dept. taken steps to rid our community of these known Dopehouses?

Shortly after the second incident, a local newspaper bore headlines that read as follows: "Special Police Squad links 25 Police Officers with Drug Rackets." Does that answer your question? There is obviously some proof to the long established claim linking Police officials and the Dope Rackets. Yesterday it was the numbers racket...today its Dope...tomorrow it may be flesh

...your Black flesh!!! There will be no reason to create illussions to kill Black People!

If STRESS can kick down your door looking for Brothers who resisted the Dopeman, then is there a difference between STRESS, Nichols, and the Dopeman?



If the occupants of the Volkswagon sprang upon the STRESS officers in a surprise attack, before they were able to defend themselves; then why was the picture (shown in local papers) of the automobile rivoted with bullet holes, and the rear window completely shot out? Critically wounded men cannot sharp shoot.

Who are the young men involved? Are they "MAD DOG KILLERS" as Police Commissioner suggests; or are they like the many other Detroit citizens who have defended themselves against STRESS: which has infact become the judge, jury, and executioner of Black People!?
