On the above date and time I, Patr Richard Worobec, was standing on the corner of John R and Belmont hold a gas can in my hand leaning against a pole. I was approached by two negro males, def #1 about 5'9" weight about 160 lbs, def #2 about 5'8" about 150 lbs. Def #1 was holding a steel rod about 18" in length and red in color in his right hand. He approached me and said "Hey man whats happening? Are you lost brother?" At this time he jabbed me in the gut with the steel rod. Def #2 at this time grabbed my right arm while #1 dropped the rod and began to remove my watch from my left hand. After def #1 grabbed my right arm he said "Give it up" Both men began to kick and hit me forcing me down to one knee. At this time I identified myself as a police officer and ordered the men to halt. Both men continued to assault me. I again ordered them to halt and again identified myself as a police officer.. When the men continued to assault me I drew my privately owned dept approved 38 cal six shot Colt Cobra serial # [REDACTED] At this point both men began to escape I again hollered "Halt Police" when the men did not stop I fired two shots at def #1, the shots did not appear to take effect, def #1 at this time was running south east on John R. Def #2 was running north west on Belmont. After firing at def# 1 I turned and fired one shot at def#2 it did not appear to take

effect I fired a second shot. I did not see def #2 fall he ran up to parked cars on the street and disappeared. At this time I turned back towards def #1 and fired two shots. Def #1 continued to run, he crossed John R and fell on the sidewalk on the east side of the street. I then went up to def #1 he was lying face down bleeding from the back and the mouth. Also he was moaning. I then called for assistance to convey def #1 to the hospital. Scout 13-8 arrived about two minutes later. When they picked def #1 up to put him on the stretcher the watch he had stolen from me dropped to the ground. The watch was placed on Evidence Tag# 992427. The steel pipe was found on the ground where def #1 had dropped it on the corner of John R. and Belmont and placed on Evidence Tag # 992428. After def #1 was conveyed to [redacted] Patr Mazzoni and myself began to search the area for def #2. We got in an unmarked scout car and drove around the area. When we got back to the original scene of the robbery and assault we noticed a crowd gathered around a parked car on the north side of Belmont facing west, just west of John R. We exited our scout car and found def #2 lying face down 1/2 on the curb and 1/2 on the street next to the car. We notified Radio that def #2 had been found and to send a wagon & several other scout cars because of the crowd. We stood by until the wagon came. 13-4 arrived and conveyed def #2 to Det. Gen. We then left the scene. My spent shells are placed on Evidence Tag # 992429.
