Department Report: This investigation by P.S.S. reveals that the complainant was arrested for D.U.I.L. by officers from the Tactical Service Section and conveyed to the Fifth Precinct. The complainant alleges that the officer stopped him without cause, thus being demeaning by calling him a nigger. The officers deny the allegations, stating the complainant was stopped after they observed him disregard a red signal and drive in an unsafe manner.

The complainant alleges an assault by officers at the precinct. Statements by the officers indicate that a struggle ensued between the doorman and the complainant after the complainant refused to turn over his property. Further that other officers had to assist in subduing the complainant. Information from a prisoner at the station stated that the complainant was loud and raising all kinds of hell at the precinct station. A statement from the officer in charge indicates the complainant was not injured during the struggle. However, the complainant was Signed
