COALITION TO ABOLISH STRESS

STRESS is a direct and murderous attack on the Black community of Detroit.. We demand that the STRESS officers be brought to trial for the murders of the 15 victims and the assault of numerous other victims lucky enough to be only wounded. Reform or modification of the STRESS program will not end the murderous or racist character of STRESS. Only the complete, total, and immediate end to STRESS will end the killing. The petition and injunction launched against STRESS are legitimate efforts to end it and should be supported. However, STRESS will not be abolished and the power of Lucas and Gribbs will not be halted only in the courts, but in the streets! Because STRESS is a racist threat to the Black community, the African-Americans of Detroit must bring their soc al weight into action in defense of their lives. No sheriff, court or jury wall end STRESS unless Blacks and all others opposed organize themselves into massive, legal demonstrations, rallies and protests demanding an end to STRESS. We seek to build a Coalition of the broadest forces possible around the demand "END STRESS NOW!" and urge all Black Detroiters and others to participate in the decision making and building of the coalition and actions needed to end STRESS: with the aim of making the streets truly safe for Blacks in Detroit.

IMPLEMENTATION

'n+i-STRESS committees should be organized in the high schools, within Block-clubs, unions, at our jobs, campuses, churches, within other organizations or wherever possible.

2. These anti*STRESS committees should organize rallies, teach-ins, press interviews picket lines and speaking engagements to a such the broadest sectors of the Black community possible, and reach out to the rest of the Detroit community. The coalition should publish literature and material getting ou the word on the true character of STRESS. These are means to build May 19th and build enthusiasm that we can and will suceed in abolishing STRESS.

3. We must continually reach out to other organizations and individuals to endorse this demonstration as well as invite them into our coalition on the basis of the principles we have laid down.
